

FEE FIXING RESOLUTION
AGONA WEST MUNICIPAL ASSEMBLY
LOCAL GOVERNANCE ACT, 2016 (ACT 936)

It is hereby resolved and approved by the Agona West Municipal Assembly in accordance with section 124, 137, 138, 139, 140, 142, 143, 144 and 145 of the Local Governance Act, 2016 (ACT 936), that the following rates, fees be charged by the Agona West Municipal Assembly for the financial year 1st January, 2025 to 31st December, 2025.

It shall be the duty of every person due to pay these Rates, Fees and Licenses or part thereof to do so in the case of annual fees on or before 31st July of the financial year. In the case of monthly fees on or before the 10th day of the month and in the case of daily fees, before 2.00 p.m. each day and 10:00 pm night fees.

Payment in all cases should be made at any Revenue Office of the Agona West Municipal Assembly or to the respective Revenue Collector or any other authorized rate collector.

PENALTIES

- Any person, who without any lawful justification or excuse refuses or neglect to pay any Fee, licenses, charges payable by him/ her on or before the stipulated date shall pay a penalty of not less **GH¢200.00 and not more than GH¢500.00** for Fees, Licenses (Business operating Fees) and permit. This is without prejudice of any action the court might impose together with the amount defaulted.
- Any person that parked or stopped his or her vehicle at unauthorised place, designated by Agona West Municipal Assembly, shall pay a fine of **GH¢700.00**. This is without prejudice of any action the court might impose together with the amount fined.
- A person who has not been authorised by the Assembly and who collects or attempts to collect any Rates/ Fees/ Licenses/permits/ levy or other charges commits an offence and is liable on summary conviction to a fine of not less than one hundred and twenty-five penalty units and not more than two hundred and fifty penalty units. This is without prejudice of any action they might impose on him or her by the court.
- The Agona West Municipal Assembly shall constitute a Task Force at any time to embark on Revenue Mobilization campaign. The Task Force shall have power to collect money owed by

defaulters and in the case of failure, lock up stores and premises of recalcitrant Rate payers and put them before court.

5. Any driver who wilfully do not stop at revenue check point or refuse to provide evidence of lorry park ticket at check point to a Revenue Collector, Task Force member or accredited agent of the Agona West Municipal Assembly shall pay a penalty of **GH¢1,000.00** and a refund of medical bills and the cost of material(s) destroyed if any. This is without prejudice of any action they might impose on him or her by the court.
6. Any person who wilfully obstruct a Revenue Collector, Task Force member or accredited agent of the Agona West Municipal Assembly to perform his/ her legitimate duty shall pay a penalty of **GH¢1,000.00** and a refund of medical bills and the cost of material(s) destroyed. This is without prejudice of any action they might impose on him or her by the court.
7. Any person who fails to pay rates, fees, permits, levies or other charges before the 31st July of the financial year, is liable for prosecution by the Agona West Municipal Assembly or any action of its authorized agent.
8. A person who makes a false statement as regards the liability of that person, to pay rates, fees, permits, levies or other charges, commits an offence and is liable on summary conviction to a fine of not more than twenty-five penalty units. This is without prejudice of any action they might impose on him or her by the court.
9. A person who incites any other person to refuse to pay any rates, fees, permits, levies or other charges payable by that person or who assists a person to make a false statement as to the liability of the person to pay rates without lawful justification or excuse, the proof of which shall be on that person, commits an offence and is liable on summary conviction to a fine of not more than twenty-five penalty units. This is without prejudice of any action they might impose on him or her by the court.
